CLOSURE INSCRIPTION PROCESS ELECTION GENERAL DIRECTOR OF CORALINA INSTITUTIONAL PERIOD JANUARY 1st, 2020 TO DECEMBER 31st, 2023

In San Andres, Island, on the fifteenth (15th) day of the month of November 2019, as Secretary of the Directive Council of Coralina, I bear witness that between the twelve (12) to the fifteenth (15) of November of this year, Sixteen (16) sealed envelopes were received in the Corporation, with documentation submitted by the candidates to be elected as General Director of Coralina, being deposited in a closed three-lock ballot box.
